

Long-time Professors Honored

Robert S. Conrad, Ph.D., and Kirby L. Jarolim, Ph.D., have been honored for 35 years of service to the OSU College of Osteopathic Medicine, where they have helped educate the more than 2,400 osteopathic physicians who have graduated from the college since 1977.

Conrad is professor of microbiology and Jarolim is chair and professor of anatomy. Both were members of the inaugural faculty at the college, which began educating osteopathic physicians at the new Tulsa school in 1974. The educators have seen the college grow from its initial class of 36 first-year medical students at a downtown Tulsa location to today's 92 first-year medical students and approximately 50 graduate students who attend classes on a modern, four-building, 16 acre campus on Southwest Boulevard.


